



#### **ADVISORY SERVICES:**

### **BECOME PART OF SOMETHING BIGGER**

The growth of the garment sector in Bangladesh is an incredible success when export statistics and employment figures are the only benchmarks used. When focusing on safety and health or working conditions though, a different story begins to unfold.

NO MATTER HOW MUCH EFFORT YOU PUT INTO YOUR FACTORY, YOU WILL STILL BE AT RISK UNTIL WORKING CONDITIONS IN THE ENTIRE SECTOR ARE IN LINE WITH NATIONAL LAW AND OTHER RELEVANT MINIMUM STANDARDS.

SINCE BETTER WORK'S ESTABLISHMENT, COMPLIANCE WITH LABOUR LAWS AND INTERNATIONAL STANDARDS HAS STEADILY IMPROVED ACROSS ALL PROGRAMME COUNTRIES.

FACTORIES IN HAITI, JORDAN AND VIETNAM HAVE SEEN A 50% IMPROVEMENT IN OCCUPATIONAL SAFETY AND HEALTH.

100% COMPLIANCE IN PAYING CORRECT MINIMUM WAGES, PAID LEAVE, AND SOCIAL SECURITY BENEFITS HAS BEEN ACHIEVED IN JORDAN AMONG FACTORIES PARTICIPATING FOR MORE THAN TWO YEARS.

We live in a generation where new communications technologies allow instant dissemination of information globally, this can be a huge opportunity or it can be a huge threat. As you know, the flexibility of supply chains and short order times make it easy for retailers to pull out of a country quickly if international pressure rises.

For this reason, Better Work does not only work at factory-level, but, through the ILO and the IFC, also at the national level.
