

Fig. 1: Employment by Major Economic Activity ('000s), 2000-2008




## Manufacturing

The manufacturing industry in Slovakia contributed 20 per cent to the country's GDP in value added terms, and provided 26.6 per cent of total jobs in 2008 (see Figs. 1 & 2). It is the single largest employer sector in the country, with 647,600 workers. Employment in the manufacturing sector increased at an average rate of 2.3 per cent per year between 2000 and 2008; faster than the 1.8 per cent average annual rate for total employment in all sectors. Manufacturing accounted for nearly one third of the net increase in jobs over this period, adding 107,200 jobs of the 332,200 total jobs added to the Slovakian economy.

In 2008 the largest sub-sectors in manufacturing, in terms of total employment, were the fabricated metal products industry (69,900 jobs); the motor vehicles, trailers and semi-trailers manufacturing industry (66,900 jobs); the electrical machinery and apparatus industry (55,400 jobs); the food products and beverages industry (54,800 jobs); and the machinery and equipment manufacturing industry (52,600 jobs). Employment growth has been strong in motor vehicles, trailers and semi-trailers and electrical machinery and apparatus, with average annual growth rates of 13.3 per cent and 11.1 per cent, respectively.

Average working time in the Slovakian manufacturing sector measured 140 hours per month in 2008, slightly higher than the national average of 139 hours per month for the total economy. Average hours of work per month in manufacturing has ranged as high as 143 hours per month (in 2001) and as low as 138 hours per month (in 2002), and has averaged 140.9 hours per month over the period 2000 to 2008. At 21,449 SKK per month, average wages in manufacturing are slightly below the national average of 21,782 SKK per month. Average monthly earnings in the manufacturing sector increased at an average rate of 7.6 percent per year between 2000 and 2008, compared to 8.1 percent per year for average monthly earnings overall.



## Fabricated Metal Products

Employment in the fabricated metal products manufacturing sub-sector has grown steadily from 52,500 workers in 2000 to nearly 70,000 workers in 2008, reflecting the growing importance of inputs for machines, including motor vehicles and parts, in the Slovakian economy (see Fig. 3). With a growing car manufacturing industry in Slovakia, the fabricated metal products industry, which supplies many important inputs for the production of motor vehicles, can also be expected to continue its growth. Fabricated metal products manufacturing continues to have a slightly higher share of manufacturing employment than the car manufacturing segment, but it has experienced a slower rate of growth than employment in car manufacturing over recent years.

The average monthly wage in the fabricated metal products industry was SKK 22,645, slightly higher than the national average wage but considerably lower than wages in the car manufacturing segment. Monthly working hours have averaged around 142 for several years, which is slightly above the national average, but comparable to the average for car manufacturing in 2008.



## **Wholesale & Retail Trade**



services Slovakia has steadily increased as a share of value added to GDP since 2000, reaching 66 per cent in 2008, with service sector employment covering 56.9 per cent of jobs in the total economy (see Figs.1 & 2). the service sector industries, wholesale and retail trade (commerce) contributes the largest share of employment and value added to GDP in Slovakia.

In 2008 the wholesale and retail trade industry employed more than 300,000 people, representing more than 12 per cent of the labour force, making it the nation's second largest employment industry. The retail trade subsector was slightly larger than the wholesale subsector, employing 156,292 people, compared to the 131,512 people employed in wholesale trade during this time (see Fig. 4). The sector overall employs more women than men, with women comprising 58.4 per cent of the workforce in 2008.

International merchandise trade (most of it carried out by wholesale merchants), has risen since 2000 with exports reaching 71.1 billion USD in 2008. Manufactures comprised 86.9 per cent of all exported goods in 2008 with primary products including passenger cars, televisions and video equipment and automotive parts. Slovakia's major trade partners include other European Union member states, the Russian Federation and the United States.

The wholesale and retail trade sector has also benefited from a 600 per cent overall increase in foreign direct investment since 2000, receiving a 13.1 per cent share of total FDI, with investments coming primarily from Austria, Germany, Cyprus, the Rep. of Korea and the Netherlands. National investments to improve air, water and road support infrastructure have also helped to support this growth in foreign trade. Despite the increase in foreign owned companies in recent years, the structure of the wholesale and retail trade industry is mainly supported by small, medium and micro-enterprises. Of the 23, 697 enterprises operating in the industry, more than 95 per cent of the enterprises have less than 20 employees. Large enterprises do play an important employment role in the country; however, as nearly 47 per cent of all employees in wholesale and retail trade are employed in large enterprises.

Overall in terms of working conditions, workers in wholesale and retail trade worked longer hours, but received slightly higher wages than the average for all industries. The average monthly wage in wholesale and retail trade was SKK 21,998 in 2008, slightly higher than the national average of SKK 21,782. Working time in the industry averaged 147 hours per month, above the national average of 139 hours.



## Construction

In 2008 the construction industry accounted for about 8 per cent of value added GDP and for about 10.5 per cent of total employment, ranking the sector third in employment, behind manufacturing and wholesale and retail trade (see Figs. 1, 2 & 5). More than 256,700 jobs were provided by the industry in 2008, and employment growth has been rapid, averaging 5.3 per cent annually from 2000 and 2008. The construction sector accounted for 89,000 out of the total net increase of 332,200 jobs between 2000 and 2008. Only manufacturing showed a larger net increase over this time. The majority of employment in construction is situated in small, entrepreneurial enterprises with less than 9 workers.



New construction starts have been strong in both residential and non-residential projects. The majority of new construction sites were centered in Bratislava and other cities including Zilina, Trnava, and Nitra. Non-residential construction also grew, largely influenced by the flow of new FDI into the country. The construction of new office buildings contributed strongly to growth in the sector. Growth in civil engineering subsectors was strengthened by national initiatives to upgrade and modernize Slovakia's roads and railway networks and airport infrastructure. Construction output has also been increasing over the past eight years, reaching a high of 6.3 billion EUR in 2008 up from 2.3 billion EUR in 2000.

Overall construction workers in Slovakia work longer hours for much lower wages than the average Slovakian worker. With respect to average working time, the construction industry is among the highest in Slovakia. In 2008 monthly working time averaged 147 hours in this industry, compared to 139 hours per month for all sectors combined. Average working hours in construction have remained relatively constant since 2000. Construction workers in Slovakia earned an average of 16,753 SKK in 2008, compared to 21,782 SKK on average for all Slovakian workers in all sectors. Only hotel and restaurant workers had lower average monthly earnings in 2008. Wages overall in the Slovakian economy have been growing since 2000, however construction sector wages have been increasing at a slower rate. While total average earnings have increased at an average annual rate of 8.1 per cent between 2000 and 2008, average earnings in the construction sector have increased only 5.8 per cent annually.




