# Progress report on developments concerning the Social Dialogue Forum set up to give effect to the recommendations of the Commission of Inquiry with respect to the Government of the Bolivarian Republic of Venezuela

- 1. Within the framework of the evaluation by the Governing Body in June 2022, of the progress made by the Government of the Bolivarian Republic of Venezuela, to implement the recommendations of the Commission of Inquiry set up to examine the complaint relating to the failure of the Bolivarian Republic of Venezuela to implement the Minimum Wage-Fixing Machinery Convention, 1928 (No. 26), the Freedom of Association and Protection of the Right to Organise Convention, 1948 (No. 87), and the Tripartite Consultation (International Labour Standards) Convention, 1976 (No. 144), at its 345th Session, the Governing Body decided to request the Director-General to:
  - (a) continue collaborating with the Government and the social partners of the Bolivarian Republic of Venezuela on the full implementation of the recommendations of the Commission of Inquiry and the effective application of Conventions Nos 26, 87 and 144 in law and practice; and
  - (b) submit to the 346th Session (October–November 2022) of the Governing Body a further report on any developments concerning the Social Dialogue Forum in order to give effect to the recommendations of the Commission of Inquiry. <sup>1</sup>

# ► Report of the Director-General on the second in-person session of the Social Dialogue Forum

(Caracas, 26–29 September 2022)

- 2. In his previous report to the Governing Body, the Director-General noted that the first inperson session of the Social Dialogue Forum had been held in Caracas, with the participation of the ILO, from 25 to 28 April 2022, with representatives of the country's tripartite constituents and the virtual participation of the Director-General, the result of which was a plan of action on the three Conventions that were the subject of the Commission of Inquiry's report. The plan of action contained an agreement to hold, in September 2022 with the ILO's technical assistance, a follow-up session of the Social Dialogue Forum concerning implementation of Conventions Nos 26, 87 and 144, and to continue in the meantime to hold bipartite meetings, as requested by the social partners, on the other matters pending in relation to the application of those Conventions.
- 3. As a follow-up to the Governing Body's decision to provide all possible support to the process, the Director-General continued to communicate freely with the Government and the social partners in the country. In particular, the Director-General held a virtual meeting with the new Minister of People's Power for the Social Process of Labour and, as a result, an agenda was produced for the second in-person session of the Forum in Caracas from 26 to 29 September 2022, combining bipartite and tripartite meetings, in the light of the recommendations made by the Commission of Inquiry (see timetable and terms of reference of the Forum in Appendix I).
- **4.** The following employers' and workers' organizations participated in the second in-person session of the Social Dialogue Forum through their spokespersons:
  - Federation of Chambers and Associations of Commerce and Production of Venezuela (FEDECAMARAS);
  - Bolivarian Socialist Confederation of Urban, Rural and Fishery Workers of Venezuela (CBST-CCP);
  - Federation of Craft, Micro, Small and Medium-Sized Business Associations of Venezuela (FEDEINDUSTRIA);
  - Independent Trade Union Alliance Confederation of Workers of Venezuela (CTASI);
  - Confederation of Workers of Venezuela (CTV);
  - General Confederation of Workers (CGT).

The Government was represented by the Minister of People's Power for the Social Process of Labour, the Deputy Ministers for the Integrated System of Labour Inspection and Social Security, and for Labour Rights and Relations, and their advisers.

- **5.** During the three and a half days of the Forum, with the good offices of the ILO officials, the tripartite constituents assessed the activities undertaken as part of the implementation of the plan of action adopted in April, that is:
  - (a) In relation to Convention No. 26, bipartite meetings were held in September between the Government and representatives of workers' (CBST-CCP, CTASI and CTV) and employers' (FEDECAMARAS and FEDEINDUSTRIA) organizations on defining the method for fixing

- minimum wages, so as to consult on the criteria to be used as a basis for the decision to increase the minimum wage, together with the reference sources for economic, social and labour data.
- (b) As regards Convention No. 144: (i) on 28 April 2022, the consultation procedures were defined for the ratified Conventions; (ii) on 15 June 2022, a virtual meeting was held between the Ministry of People's Power for the Social Process of Labour (MPPPST) and the ILO on the requested reports; (iii) between 15 July and 10 August 2022, the Government shared the draft reports with the employers' and workers' organizations that had signed the plan of action; and (iv) on 9 and 11 August, the Government held two meetings, with the workers' and employers' organizations that had signed the plan of action, with a view to publishing the respective reports.
- (c) Finally, with respect to Convention No. 87: (i) on 24 August 2022, the ruling of 14 May 2021 to dismiss the case brought against a former President of the Venezuelan Confederation of Industrialists (CONINDUSTRIA) was approved; <sup>2</sup> and (ii) in relation to registration procedures and processes for union elections, on 6 May and 24 and 25 August 2022, the records of the annual assemblies of FEDECAMARAS (2018–21) were entered in the corresponding Secondary Register of Records. Two workshops were also organized on the subject with employers' and workers' organizations. <sup>3</sup> More details on these activities are included in the communications received from the Government and the other social partners, summarized below.
- **6.** During the second Forum, the need was highlighted to comply with the deadlines for implementing the plan of action and to produce brief notes at the end of the meetings containing a summary of the agreements and the next steps. In the case of Convention No. 144, agreement was reached to bring forward the start of the preparatory work for the dispatch of the 2023 reports and to submit the draft reports at least two weeks prior to the meetings at which the reports are made available to the social partners. Likewise, the possibility was raised for the organizations concerned, where appropriate, to submit evidence to the MPPPST, concerning the presumed violations of Convention No. 87, so that they may be dealt with effectively.
- 7. The participants in the second Forum agreed to update the plan of action (see Appendix II). The ILO constituents in the country recognized: (i) the importance of continuing to implement the plan of action concerning Conventions Nos 26, 87 and 144, a decision adopted at the first in-person session of the Social Dialogue Forum in the Bolivarian Republic of Venezuela (adopted on 28 April 2022); (ii) the importance of guaranteeing the measures for the exercise of freedom of association, including the optional nature of the assistance provided by the National Electoral Council (CNE) to trade union organizations in their elections, and (iii) the willingness of all the signatories to continue with the social dialogue process in following up on the decisions of the ILO Governing Body, relating to the recommendations made by the Commission of Inquiry. On that basis, they agreed to:
  - (a) update the plan of action adopted at the first in-person session of the Social Dialogue Forum in the Bolivarian Republic of Venezuela (April 2022), as follows: (i) set up a round table to devise the methods of fixing the minimum wage and hold a dialogue on other

related matters; (ii) adopt and implement an agreed timetable on effective annual consultation relating to international labour standards; and (iii) since trade union elections are independent and, where they are held, undertake a plan of work with the electoral authority for the guidance and advice given to trade union organizations in their electoral processes, where they so request, bearing in mind the discussions held at the meeting between the workers' organizations and the CNE;

- (b) organize a follow-up session of the Social Dialogue Forum in February 2023, in accordance with the decision taken by the ILO Governing Body to deal with the subjects relating to compliance with Conventions Nos 26, 87 and 144;
- (c) continue with the process of social dialogue so as to tackle the issues included in the timetable of activities; and
- (d) request the ILO's technical assistance on matters relating to updating the plan of action.
- **8.** The timetable which, as an appendix, forms part of the follow-up to and updating of the plan of action, includes the following activities relating to the three Conventions:
  - (a) **Convention No. 26**: (i) setting up of a round table to devise the methods for fixing the minimum wage and hold a discussion on methodology and relevant indicators and sources for these and other related subjects; and (ii) organization of two training workshops for workers' and employers' organizations relating to indicators and methodology for fixing minimum wages.
  - (b) Convention No. 144: (i) development of training programmes (one of these prioritizes Conventions for which a report is requested); (ii) holding of a preparatory meeting for the International Labour Conference; (iii) dispatch by the Government of draft reports on ratified Conventions, sufficiently in advance and grouped by subjects, to employers' and workers' organizations; and (iv) holding of thematic meetings with representatives of employers' and workers' organizations in order to make the reports available.
  - Convention No. 87: (i) processing of evidence of presumed stigmatization and discrediting of parties, including the submission to the relevant authorities by the organizations concerned of updated lists with information to identify the cases of evidence relating to the Government, and the holding of bipartite meetings between the Government and employers' and workers' organizations to consider and take relevant measures, and follow up on them; (ii) effective processing of evidence relating to cases of detentions and judicial proceedings or preventive measures as an alternative to detention, presumed to relate to the exercise of lawful trade union activities, including the submission of up-to-date lists (with information identifying cases) of evidence previously corroborated by each sector concerned, its individual submission to the Public Prosecutor's Office and other authorities concerned, and the holding of bipartite meetings to take the relevant measures; (iii) effective processing of evidence relating to trade union registration procedures and election processes, including the communication thereof by the organizations concerned, analysis, determination of relevant measures and information for the relevant organizations by the MPPPST, and the continuation of dialogue on the assistance provided by the CNE to trade union organizations in their electoral processes, where they request it; and (iv) processing of and effective follow-up to the evidence of presumed interference by Workers' Production Councils in the independence of employers' and workers' organizations, or in the relations between them, including the communication to the MPPPST of evidence by the organizations concerned, the conduct of inquiries and determination of measures to ensure that no

interference takes place and the relevant corrective measures are applied by the MPPPST, information is sent to the organizations concerned, and consultations held relating to the adoption of the Regulations under the Constitutional Law of the Workers' Production Councils.

- 9. On 28 September 2022, the Director of the International Labour Standards Department and officials from the Bureau for Workers Activities (ACTRAV) held a meeting with representatives of the following trade union confederations: National Union of Workers of Venezuela (UNETE), Confederation of Autonomous Trade Unions (CODESA), Single Confederation of Workers of Venezuela (CUTV) and the National Trade Union Coalition, during which the trade union representatives in question informed them that they had not been invited to participate in the second in-person session of the Social Dialogue Forum and requested their support to ensure that they were included in future sessions of the Forum. They also shared various pieces of additional information.
- **10.** On the same day, the President of the CNE met with the representatives of the trade union confederations, CBST-CCP, CTASI, CTV and CGT, to hold a discussion on the technical advice and guidance functions provided by the Council in the electoral processes of the trade union organizations that request them.
- 11. When the Forum was held, measures were confirmed relating to the detention of three trade union representatives, held by the Directorate-General of Military Counter Intelligence (DGCIM) between 5 and 7 July 2022, and accused of the crimes of conspiracy and association with criminals, that is: Mr Emilio Negrín, President of the Federation of Court Workers, and a participant in the Social Dialogue Forum in April 2022, Mr Gabriel Blanco, Director of the Union of Workers of the National Assembly and CTASI, and Mr Reynaldo Cortés, a trade union representative of the CTV in the State of Guárico. It was also reiterated at the Forum that Mr Rodney Álvarez, a trade unionist, was released from an 11-year term of imprisonment, a decision that was confirmed without restrictions. Similarly, the Minister of People's Power for the Social Process of Labour was reminded that the request for reinstatement and the granting of fair compensation for the 11-year term of imprisonment, filed by Mr Álvarez, was still pending. <sup>4</sup>

# ▶ Additional information on the implementation of the Plan of Action in application of the recommendations made by the Commission of Inquiry

12. In addition to the communications contained in the Director-General's report presented to the Governing Body in June 2022, <sup>5</sup> the Office received further communications from the Government on 21 July, 4 and 31 August, 13 September, and 3, 4 and 20 October 2022, from FEDECAMARAS on 1 September 2022, CTASI and CTV on 10 June 2022, UNETE and CODESA on 5 July 2022, and CTASI on 29 September 2022. Their content is summarized below and the texts of said communications, as well as the appended documents referred to in the communications, are available to Governing Body members for consultation.

### Information sent by the Government

**13.** In a communication of 21 July 2022, the Government stated that between 13 and 19 July bilateral meetings were held with the CBST-CCP, CTV, CTASI and CGT trade union confederations, and the FEDECAMARAS and FEDEINDUSTRIA employers' organizations, in order to discuss the various subjects relating to Conventions Nos 26, 87 and 144.

- In a communication of 4 August 2022, the Government indicated that, as a follow-up to the virtual meeting with the Director-General on 27 July 2022, taking into account the principles of separation of powers and collaboration, it had contacted the Public Prosecutor's Office which, in relation to the cases discussed at the above meeting, informed it that: (i) Mr Emilio Negrín and Mr Gabriel Blanco were monitored for belonging to a subversive organization conspiring against the Government, the self-styled "Popular Resistance Unit"; (ii) their active participation in such an organization gave rise to plans designed to harm the Government, intended to sabotage and hinder the National Festival day on 5 July, in which the President of the Republic and senior military officials, together with other high authorities, would participate; (iii) they had been detained on the basis of the summary investigations conducted and evidence collected by the Public Prosecutor's Office, and were charged with the crimes of conspiracy and association with criminals, as provided for and sanctioned by the Criminal Code; (iv) the detentions bore no relation to the exercise of trade union activities by the persons concerned; and (v) the ILO would be kept informed with respect to their trials. As regards Mr Pablo Zambrano, the Executive Secretary of the Federation of Health Workers (FETRASALUD), the Government added that he had not been detained, as proven by his various trade union activities.
- **15.** In a communication of 31 August 2022, the Government provided information in addition to its previous communications, to the effect that at the bilateral meetings mentioned in its communication of 21 July 2022, FEDECAMARAS informed the Government that it had been notified of the decision on 14 May 2021 of the 23rd Itinerant Court of First Instance responsible for reviewing dismissals under the Criminal Judicial Circuit of the Caracas Metropolitan Area, in which the case against Mr Eduardo Garmendia, the former President of CONINDUSTRIA, had been dismissed. As regards Convention No. 144, the Government indicated that: (i) it carried out effective consultations in the process of producing reports on the application of Conventions and Recommendations; (ii) it submitted the draft reports to workers' and employers' organizations as of 15 July 2022; and (iii) on 9 and 11 August, it had summoned those organizations to meetings to discuss the content of the draft reports. The Government added that the MPPPST was in the process of reaching agreement with the legislature, at the request of the social partners, on the participation of workers' and employers' organizations in the consultation phase of laws containing special arrangements on working conditions and the bill on workers with disabilities. In relation to Convention No. 87, the Government indicated that on 24 and 25 August 2022, two workshops had been held with workers' (CBST-CCP, CTASI and CTV) and employers' (FEDECAMARAS and FEDEINDUSTRIA) organizations on the procedures and requirements established in legislation, with respect to the National Register of Trade Union Organizations. The Government added that on 23 August 2022, the associations and chambers of the production sectors headed by the Presidents of FEDECAMARAS and FEDEINDUSTRIA had been incorporated in the National Council on the Productive Economy at a new meeting of the Council, led by the President of the Republic. The Government indicated that the meeting was intended to devise strategies to strengthen the country's different production sectors.

16. In a communication of 13 September 2022, the Government stated that on 7 and 12 September bipartite meetings were held by the Government with representatives of workers' (CBST-CCP, CTASI and CTV) and employers' (FEDECAMARAS y FEDEINDUSTRIA) organizations, within the framework of the follow-up activities stemming from the plan of action agreed in April 2022, in order to make progress with the definition of the method for fixing minimum wages and consult on criteria and sources of economic, social and labour reference data linked to the analysis for fixing minimum wages. The Government indicated that at those meetings, held in a climate of respect and good will, the social partners and government representatives expressed their different points of view and their interest in continuing to work to define the method for fixing the minimum wage, which must remain over time but also take into account the current economic situation in the country. Likewise, the social partners made it clear that: (i) it is important for consultation meetings to be held in a structured and formal manner; (ii) they were interested to know how the indicators and elements are devised for the interpretation of data, by the National Statistics Institute (INE) and the Central Bank of Venezuela (BCV), for which reason a training activity with the Ministry of People's Power for Planning is scheduled; and (iii) the proposal put forward by the Government on the methods for fixing minimum wages, as part of the large-scale social dialogue in 2021, could serve as a basis for devising an agreed method of fixing minimum wages. The Government also indicated that the FEDECAMARAS representatives proposed producing a study on the various sources, in addition to the official one, which generate the basic basket of goods indicator.

- 17. In its communications of 3 and 4 October 2022 sent to the ILO Director-General, the Government reiterated its gratitude for the ILO's support and technical assistance, which it hopes to continue receiving in the future. It also indicated its willingness to continue strengthening the application of the Conventions and agreements signed and ratified with the ILO.
- In its communication of 20 October 2022, the Government provided information on the following activities to implement the plan of action agreed in Caracas in September 2022: (i) on 11 October 2022, the public consultation was held with the employers' and workers' organizations on the Homeworkers' Act, in which the CBST-CCP, CTASI, CTV, CGT, FEDECAMARAS and FEDEINDUSTRIA participated; (ii) on 19 October 2022, a meeting was held with FEDECAMARAS and FEDEINDUSTRIA to make progress in defining requirements and procedures for the national registration of those organizations, and a round table was set up at which the proposals presented by the social partners were discussed; and (iii) on 20 October 2022, a tripartite meeting was held with the organizations affected by the results of the Social Dialogue Forum on the setting-up of a round table relating to the application of Convention No. 26. Similarly, the annex to the communication includes the detailed timetable of the activities planned until February 2023, for which purpose it is hoped that the ILO will provide technical assistance. The Government emphasized that it hoped that the third session of the social dialogue forum would take place from 6 to 10 February 2023. With respect to the request made by Mr Rodney Álvarez to be reinstated in his job and to receive the payment of lost wages and other benefits that he stopped receiving from the time when he was taken into detention, in Administrative Ruling No. 001 of 17 October 2022 the Labour Inspectorate of Puerto Ordaz ordered the labour body to pay all sums relating to Mr Álvarez's labour rights. It also dismissed the request to reinstate Mr Álvarez in his job, on the grounds that the case had lapsed, as the time period established in article 34(c) of the Regulations under the Basic Labour and Workers Act had expired. As regards the cases of Mr Emilio Negrín and Mr Gabriel Blanco, the Government stated that their detention was in line with the law, that the criminal trial against them related to the fact that they were presumed to have committed serious offences provided for under the Venezuelan legal system, and that the trial bore no relation to the exercise of

their trade union rights (the full text of the communication is contained in Appendix III of this document).

## Information sent by FEDECAMARAS

- 19. In a communication of 1 September 2022, FEDECAMARAS indicated that although meetings were held between the parties in a respectful and cordial atmosphere, the dialogue process is subject to delays and weaknesses, as no structured tripartite consultation body has been set up and the meetings do not comply with the formalities recommended by the Commission of Inquiry and other ILO supervisory authorities (independent chair or secretariat, recording of minutes, agreed timetable of meetings, follow-up mechanisms on compliance with agreements).
- **20.** In its detailed report attached to its communication, FEDECAMARAS indicated for each Convention:
  - (a) Convention No. 26: (i) the in-person meetings planned for July 2022 with the presence of the social partners, relevant technical specialists and official authorities concerned, to consult on reference criteria and data available for fixing the minimum wage, had not taken place by the beginning of September; and (ii) it is essential to hold tripartite consultations on methodology and have available official indicators such as Gross Domestic Product (GDP), labour market, normative food basket, etc., together with indicators of various sources.
  - (b) Convention No. 87: (i) on 6 May 2022, annual assemblies of FEDECAMARAS were entered in the Secondary Register of Records, corresponding to 2018, 2019, 2020 and 2021; (ii) on 23 August 2022 the President and other leading FEDECAMARAS officials were invited to the event of the National Council on the Productive Economy which included announcements on taxation and rates of collection, and the Government's intention to develop a new diversified economic model which is less dependent on oil; (iii) on 24 August 2022, the ruling of 14 May 2021 to dismiss the case brought against Eduardo Garmendia, former President of CONINDUSTRIA and former Treasurer of FEDECAMARAS, was approved by the 23rd Itinerant Court of First Instance responsible for reviewing dismissals under the Criminal Judicial Circuit of the Caracas Metropolitan Area, owing to lack of evidence in the events which occurred in 2014; (iv) as regards the list of large farms prioritized with measures for recovering land by the National Land Institute (INTI), identified by FEDECAMARAS for its priority attention, meetings were held between the parties concerned and that body to seek solutions, although no land was actually returned to the lawful owners, other than progress made by the INTI in the process of relocating the occupiers of two of the large farms contained in the list in question: Large farm 75 and Boralito Agricultural, S.A.; (v) on 12 August 2022, the union leader in Bolívar State and Second Principal Director of the Chamber of Commerce and Industry of the General Manuel Cedeño Municipality of Bolívar State, Mr Mario Manuel Lara Osto, was detained and charged with allegedly committing offences relating to the sale of gas; (vi) on 29 and 30 August 2022, the National Assembly deputy for Yaracuy, Mr Braulio Alvarez, disseminated hateful and intimidatory messages against the President of FEDECAMARAS, Mr Carlos Fernández, and of the Stockbreeders' Federation of Venezuela (FEDENAGA), Mr Armando Chacín, and other union leaders, as part of the process of returning occupied lands; (vii) the formation and activities of workers' production councils continue to be promoted, with 2,555 councils having been set up in companies; the President of the Republic mandated the MPPPST to draft regulations for such Councils, and a diploma in labour leadership is offered for Councils in companies in order to strengthen, among

other processes, the communication of information to the Deputy Minister for Education and Labour for Liberation, and on 30 August 2022, an attempt was made to set up a workers' production council in Procter & Gamble Lara State, but the Union of Workers of the company Procter & Gamble Barquisimeto (SINTRAPROB) declined and no workers wished to participate; (viii) on 25 August 2022, a workshop was held with employers' organizations (FEDECAMARAS and FEDEINDUSTRIA) on the Register of Trade Union Organizations. On this occasion, FEDECAMARAS reiterated the need for confidentiality and preservation of the commercial value of the lists of members, and their position whereby the relevant standards do not apply to employers' organizations; and (ix) meetings were held on various subjects with representatives of the MPPPST.

(c) **Convention No. 144:** (i) on 9 August 2022, a meeting of the FEDECAMARAS and FEDEINDUSTRIA employers' organizations was held, led by the Deputy Minister for the Integrated System of Labour Inspection and Social Security, in order to obtain verbal comments on the draft reports submitted in the previous few days, via email; (ii) although there is an improvement in the consultation process, the reports still need to be made available earlier and a larger number of meetings held to review them; (iii) the direct consultation mechanism for workers' and employers' trade union organizations concerning labour and social and economic legislation of relevance and interest to the social partners has not been effective, since a number of laws, including the Basic Law on Special Economic Zones of 30 June 2022, have been published without consultation; and (iv) in July and August 2022, ten laws were approved upon first discussion, also without consultation, including the draft Special Workers with Disabilities Act and the Homeworkers Act.

## Information sent by the workers' organizations

- 21. In a communication of 10 June 2022, CTASI and CTV requested the ILO's urgent intervention owing to the threats received by Mr Pablo Zambrano, the Executive Secretary of the Federation of Health Workers (FETRASALUD). In the communication, they stated that after participating in a peaceful demonstration called by FETRASALUD in relation to the human and labour rights of health workers and their levels of remuneration, Mr Zambrano received, via various social networks, public threats, inciting hatred and which could put his physical integrity and that of his family at risk. The communication also indicated that action would be taken on this situation with the competent authorities in the Bolivarian Republic of Venezuela, including before the Public Prosecutor's Office.
- 22. In a communication of 5 July 2022, UNETE and CODESA requested the ILO's urgent intervention, alleging: (i) the arbitrary detention of the President of the Federation of Court Workers (Mr Emilio Negrín) by officials of the Directorate-General of Military Counterintelligence (DGCIM), who arrived at his residence during the morning of 5 July 2022; and (ii) that Mr Negrín was transferred to one of the head offices of the Bolivarian National Intelligence Service (SEBIN). The communication also indicated that Mr Negrín participated in the Social Dialogue Forum that took place from 25 to 28 April 2022.
- 23. In a communication of 29 September 2022, the CTASI workers' organization submitted a list, corresponding to the period from January 2014 to September 2022, indicating 88 cases of custodial detention, preventive measures and alternatives to detention, and judicial proceedings against union leaders and workers, as well as information on the cases of workers that have been freed.

\* \* \*

**24.** It is now the responsibility of the Governing Body to decide how to proceed in the light of the available information, following up on its previous discussions in November 2020, March, June and November 2021, and March and June 2022. <sup>6</sup>

### Draft decision

- 25. The Governing Body, on the recommendation of its Officers:
  - (a) recognized progress made while reiterating its call to the Government of the Bolivarian Republic of Venezuela to accept the recommendations of the Commission of Inquiry;
  - (b) requested the Director-General to continue collaborating with the Government and the social partners of the Bolivarian Republic of Venezuela on the full implementation of the recommendations of the Commission of Inquiry and the effective application of the Minimum Wage-Fixing Machinery Convention, 1928 (No. 26), the Freedom of Association and Protection of the Right to Organise Convention, 1948 (No. 87), and the Tripartite Consultation (International Labour Standards) Convention, 1976 (No. 144) in law and practice; and
  - (c) requested the Director-General to submit to the 347th Session (March 2023) of the Governing Body a further report on any developments concerning the Social Dialogue Forum and the implementation of the agreed action plan to give effect to the recommendations of the Commission of Inquiry.

# Terms of reference of the follow-up session of the Social Dialogue Forum in the Bolivarian Republic of Venezuela

(Caracas, 26-29 September 2022)

Participants: all the organizations representing employers and workers that signed the
Declaration of the First Social Dialogue Forum, and those which subsequently acceded to the
Declaration, will be invited, together with the authorities of the Ministry of People's Power for
the Social Process of Labour.

#### 2. ILO technical assistance and other matters:

- (a) The ILO will provide technical assistance in the sense that such assistance must be given as a whole, in application of the decisions of the Governing Body in November 2021 (GB.343/INS/9(Rev.1)/Decision), March and June 2022 (GB.344/INS/14(Rev.1)/Decision) and GB.345/INS/5/1(Rev.1)/Decision), and Conventions Nos 26, 87 and 144 shall be fully implemented.
- (b) Although the organization, logistics and other general responsibilities concerning the holding of the Forum are entrusted to the national authorities, the ILO will continue to facilitate the smooth running of the sessions.
- (c) The Government will provide catering services to all participants in the Forum in the same place where the event is held.

#### 3. Subjects for discussion:

- (a) Progress report on the plan of action resulting from the Social Dialogue Forum and the timetable of activities by Convention (see Appendices I and II).
- (b) All the pending matters relating to the application of the Conventions concerned, including the following non-exhaustive list:

#### • Convention No. 26:

o The measures necessary to establish procedures, authorities or other institutionalized forms of social dialogue in order to ensure effective tripartite consultation with no exclusions on the fixing of the minimum wage.

#### • Convention No. 87:

- o The measures necessary to guarantee a climate in which the social partners may carry out their lawful activities, ensuring full respect for civil liberties and trade union rights, including consultation processes on normative issues.
- o The measures necessary to guarantee respect for the independence of employers' and workers' organizations.

#### Convention No. 144:

- o Report on the consultation process that took place during the preparation of the 2022 reports.
- o Discussion of additional measures for the appropriate functioning of effective tripartite consultation procedures.

- (c) Follow-up mechanisms:
- Forum follow-up session (February 2023);
- updating of the timetable for the enforcement of all the agreements concluded;
- arrangements for ILO technical assistance to support enforcement of the agreements.

# 4. Guarantees, objectives and methodology, together with information for the ILO authorities:

- (a) The Forum implies the commitment of all the parties to respect the essential preconditions for an effective social dialogue, conducted in good faith and with real impact, with all the guarantees respecting the independence and autonomy of the employers' and workers' organizations, and the agreements reached.
- (b) The main objective of the Forum is to facilitate compliance with the ILO Governing Body decision of November 2021 and achieve specific results.
- (c) The following are highlighted as initial objectives to facilitate the work and its impact on the application of the Conventions concerned:
  - reaffirm the commitment of all the parties to make progress in good faith in complying with Conventions Nos 26, 87 and 144, in the light of the comments made by the ILO supervisory authorities;
  - identify and prioritize the pending issues;
  - agree on the most appropriate arrangements and the timetables for their effective introduction so as to achieve specific results, and follow-up mechanisms that are relevant, including the assistance which may be requested from the ILO.
- (d) Minutes: minutes will be prepared for sessions, to reflect any agreement or commitment made as a result of the Forum. The Office will be available to produce draft minutes of the sessions of the Forum, if the tripartite constituents consider it relevant.
- (e) Information for ILO supervisory authorities: the results of the Forum shall be transmitted for information and consideration by the ILO Governing Body and also to the Committee of Experts on the Application of Conventions and Recommendations (CEACR).
- 5. **Tripartite adoption:** This document has been adopted in consultation with the Forum participants.

# Follow-up to and updating of the plan of action resulting from the Social Dialogue Forum in the Bolivarian Republic of Venezuela

The ILO constituents in the country, meeting in Caracas from 26 to 29 September 2022 within the framework of the second session of the Social Dialogue Forum and represented by the authorities and organizations indicated below,

Recognizing the importance of continuing to implement the plan of action relating to Conventions Nos 26, 87 and 144, resulting from the first in-person session of the Social Dialogue Forum in the Bolivarian Republic of Venezuela (adopted on 28 April 2022), described in detail in the annex,

Recognizing the importance of guaranteeing the measures for the exercise of freedom of association, including the optional nature of the assistance provided by the National Electoral Council (CNE) to trade union organizations in their elections,

Recognizing the willingness of all signatories to continue with the social dialogue process as a follow-up to the decisions of the ILO Governing Body, relating to the recommendations of the Commission of Inquiry,

#### Agree to:

- Update the plan of action adopted at the first in-person session of the Social Dialogue Forum in the Bolivarian Republic of Venezuela (April 2022), as follows: (i) set up a round table to devise the methods for fixing the minimum wage and discuss other related subjects; (ii) adopt and implement an agreed timetable on the effective annual consultation relating to international labour standards; and (iii) trade union elections shall be independent and, when they are held, a plan of work shall be launched with the electoral authority to provide guidance and advice to trade union organizations in their electoral processes, where they so request, taking into account the agreement reached at the meeting between the workers' organizations and the CNE. Such activities are described in detail in the annex.
- Organize a follow-up session of the Social Dialogue Forum in February 2023, in accordance with the decision of the ILO Governing Body, to deal with the issues relating to compliance with Conventions Nos 26, 87 and 144.
- Continue with the social dialogue process to deal with the subjects included in the annex.
- Request the ILO's technical assistance on the subjects related to updating the plan of action.

# Communication of the Government of the Bolivarian Republic of Venezuela (20 October 2022)

Honourable Director-General Houngbo,

I would like to take this opportunity to convey to you the greetings of the President of the Bolivarian Republic of Venezuela, Mr Nicolas Maduro Moros.

I would also like to inform you that as part of the results of the recently completed Social Dialogue Forum, held in Caracas from 26 to 29 September 2022, a timetable of work was produced for the enforcement of the plan of action resulting from the discussions, which is planned to continue from October 2022 until February 2023.

In that regard, I would like to inform you of some of the activities referred to in the above plan of work, that have taken place to date, which demonstrate our permanent commitment to the policy of strengthening social dialogue with the various social partners in the Bolivarian Republic of Venezuela, as well as our unfailing willingness to continue enhancing in the country the application of ILO Conventions Nos 26, 87 and 144. These activities include, in particular:

- On 19 October 2022, the sectoral meeting was held with the employers' organizations, FEDECAMARAS and FEDEINDUSTRIA, in order to make progress in defining requirements and procedures for the national registration of those organizations, in accordance with the current legal rules in Venezuela. For that purpose, a round table was set up, at which the proposals presented by the social partners were discussed, and we will continue working towards that goal.
- On 20 October 2022, a tripartite dialogue meeting was held with the workers' and employers' organizations affected by the results of the Social Dialogue Forum, at which discussions concerned the setting-up of a round table relating to the application of Convention No. 26 on the methods for fixing the minimum wage and other subjects of interest for the social partners. It is important to emphasize that the discussions took place in an atmosphere of respect and good will, and we are sure that we will continue progressing in that direction and produce relevant specific results.
- As regards the consultation with the social partners, on laws relating to the world of work, and specifically those which stem from or complement the Basic Labour and Workers Act, in accordance with the obligations resulting from Convention No. 144 on tripartite consultation, on 11 October 2022 the public consultation on the Homeworkers Act was held with the workers' and employers' organizations at the headquarters of the legislative authority, through the good offices of the Ministry of People's Power for the Social Process of Labour, in conjunction with the National Assembly. Representatives of the CBST-CCP, ASI-Venezuela, CTV, CGT, FEDECAMARAS and FEDEINDUSTRIA participated. Similarly, it is

hoped that the consultation on the Workers with Disabilities Act will be held in the coming days.

• As for the case of Mr Rodney Álvarez, identity card number 19.184464, following his request to the labour inspectorate of the city of Puerto Ordaz, Bolívar State, in which he claimed reinstatement in his job, and payment of lost wages and other benefits that he stopped receiving from the time when he was taken into detention, on 17 October 2022 the labour inspectorate issued Administrative Ruling No. 001, in accordance with the Basic Administrative Procedures Act, through which it orders the labour body inter alia to pay all sums relating to the labour rights of the citizen in question and dismisses the request for Mr Álvarez to be reinstated in his job, on the grounds that the case has lapsed, since the time period specified in article 34(c) of the Regulations under the Basic Labour and Workers Act has expired.

Similarly, Director-General, it is important to emphasize that it is planned to examine the case of the Bolivarian Republic of Venezuela during the 346th Session of the Governing Body, on 7 November 2022. It is planned to carry out other bipartite and tripartite activities linked to the application of Conventions Nos 26, 87 and 144, and we hope to provide information on the results of these activities within the same Governing Body session.

Likewise, as of the second half of November until February 2023 we hope to carry out other consultation and training activities with the social partners, for which purpose we hope to receive the valuable technical assistance of the ILO multidisciplinary team, both from its headquarters in Geneva and from the Regional Office for Andean Countries located in Lima. It is also planned to hold the third session of the Social Dialogue Forum from 6 to 10 February 2023.

Furthermore, in relation to the cases of assumed failure by the Venezuelan Government to comply with Convention No. 87, in the specific cases of Mr Emilio Antonio Negrín Borges and Mr Gabriel José Blanco Flores, we wish to state that their detention is in line with the provisions of the Constitution of the Bolivarian Republic of Venezuela, national laws and the international human rights treaties signed and ratified by the country. The criminal proceedings brought against them relate to the fact that they are presumed to have committed serious offences, provided for in the Venezuelan legal system, and bear no relation to the exercise of trade union rights. In addition, in the course of the proceedings the Venezuelan legal system makes available to the accused persons a series of judicial resources in order to guarantee their rights. Finally, the Bolivarian Republic of Venezuela confirms its willingness to continue providing information on the development of this case, as part of its commitment to cooperate with the competent international organizations, as is the case with the ILO.

In conclusion, Director-General, we reiterate the content of our communication No. 1130 of 3 October 2022 and again express the firm willingness and interest of our Government in complying with the commitments resulting from the second session of the Social Dialogue Forum, for which purpose we hope to continue counting on the support which the ILO has always offered to the actors in the world of work that operate in the Bolivarian Republic of Venezuela.

I take this opportunity to renew to you, Director-General, the expression of my highest consideration.
